2025 EOY Closing - Locating Campus Loading Zones

Residential students must depart their residences within **24 hours** of the conclusion of their last spring 2025 exam or by noon on **Saturday, May 10**, whichever comes first. Only graduating students, those approved to assist with commencement, apartment residents participating in 12-month housing, or students working with select faculty/staff-sponsored department (i.e., some athletes, Brock Experiences) may stay in the residence halls/apartments <u>beyond</u> **noon on Saturday, May 10**.

Johns Hall and Moss Hall

(Use GPS Address: 515 S. Main Street Farmville, VA 23901)

From South Main Street, enter campus at Wynne Drive. Turn right onto Pine Street, and then turn onto the sidewalk in front of the Pierson Fitness Center. Vehicles may not be left unattended, blocking others. In order to maintain a safer ONE-WAY traffic flow, vehicles will not be permitted to enter Redford Street from South Main Street (at the McDonald's intersection). Instead, use Redford Street to only EXIT campus. Starting Friday morning, April 25, the Moss/Johns 15-minute loop (on the South Main Street side of the buildings) will be CLOSED as the sidewalk access over to Spruce Street is OPENED. These traffic management arrangements will be in effect until Monday, May 19.

Lancer Park

(Use GPS Address: 899 Clubhouse Circle Farmville, VA 23901)

From Third Street, enter the Lancer Park community at Cormier Drive.

Longwood Landings

(Use GPS Address: 150 S. South Street Farmville, VA 23901)

From South Main Street, turn onto Putney Street. Enter the Longwood Landings community at South Street, (entrance adjacent to McDonald's).

Register Hall and Sharp Hall

(Use GPS Address: 508 Vine Street Farmville, VA 23901)

From Griffin Blvd., enter campus at Vine Street or Redford Street. Use designated loading/unloading spaces on Race Street, in front of Register Hall and Sharp Hall, loading/unloading street areas on Redford Street, or two spaces within the Reid Lot.

Stubbs Hall

(Use GPS Address: 306 Griffin Blvd Farmville, VA 23901)

From Griffin Blvd., enter campus at Redford Street or Madison Street to utilize the designated loading/unloading street spaces. A minimal quantity of loading/unloading spaces will also be available in the Cox Hall Parking Lot, a commuter student lot.

Wheeler Hall

(Use GPS Address: 114 Griffin Blvd Farmville, VA 23901)

From Griffin Blvd., enter campus at Madison Street to utilize the designated loading/unloading street spaces. A minimal quantity of loading/unloading spaces are available in the Jarman Parking Lot, located at the end of Madison Street.

The Wheeler Hall Parking Lot, located near the intersection of Griffin Blvd. and High Street, is accessed from Griffin Blvd. That faculty/staff lot will have a minimal quantity of loading/unloading spaces.

Expectations and Best Practices:

- Do not park in private business parking lots. Towing is strictly enforced.
- Students should continue parking in their designated parking permit zone.
- Remain vigilant and patient with other pedestrians and vehicles.
- Students are encouraged to bring their own dollies or handcarts to expedite the transferring of personal property.
- Do not illegally park on campus or attempt entry into restricted/barricaded areas.
- Take necessary measures to ensure self-care.
